Message from the Executive Director



بسم الله الرحمن الرحيم

As-salaamu 'alaikum wa rahmatu Allah, Greetings and may the peace and blessings of God be upon you,

I was once asked by a community member to identify CAIR-NY's "ultimate" goal. I paused for a moment to reflect on the many ambitions we undertake towards fighting Islamophobia, racism and xenophobia. Then I replied that our bottom line goal is to create a world in which our services are **no longer needed...**

A WORLD IN WHICH DISCRIMINATION IS ERADICATED AND OUR COMMUNITY IS EMPOWERED.

As it stands today, discrimination against Muslims is still rampant. The numbers prove that. CAIR's 2022 Civil Rights Report, *Still Suspect: The Rise of Islamophobia*, cites a record number of complaints: **6,720** requests for assistance with discrimination and bias incidents nationwide.

In New York, 2022 reaffirmed the need to grow CAIR-NY's immigration-related work. The immigration system is not just broken, but it heavily discriminates against Muslims. We took on our first in-house immigration matter in 2019 with a successful lawsuit to compel USCIS to schedule a naturalization oath ceremony for our client, an Albanian Muslim New Yorker, after a 58 month delay. Since then, we've continued the work to end family separation with litigation for individual families. We also have embarked on massive advocacy campaigns, like our Yemeni Repatriation effort bringing home hundreds of Yemeni Americans stuck in a war torn country due to COVID-19 travel restrictions. To extend this work, CAIR-NY is committed to hiring another full time attorney, inshaAllah (God willing).

Our team's efforts also grew with the onboarding of CAIR-NY's first full-time Communications staff member. The investment has already resulted in the expansion of our digital and print media, including a robust library of community resources, and our first major research based publication entitled *Feeling the Hate: Bias and Hate Crimes Experienced by Muslim New Yorkers*. Coupled with dozens of educational community workshops, this data-driven report has been cited by elected officials and journalists alike to amplify the voices of Muslim Americans who have experienced hate crimes and bias incidents.

CAIR-NY recognizes the continued need to grow our services in accordance with the needs of our community. InshaAllah, with your support, these services will ultimately end discrimination against Muslims and all communities.

As always, we thank you for standing with CAIR-NY. Let's continue to grow in 2023 together.

Our Legal & Advocacy Work

PASSISTANCE ASSISTANCE

CAIR-NY provides free legal services for individuals who are faced with anti-Muslim discrimination or harassment. In 2022, we answered 243 requests for assistance from across New York State from those who lacked legal representation.

The continued fight for justice, inclusion, and fairness for all Muslims in New York requires a team dedicated to the task. That's why our free services and legal counsel are designed for our community members to learn about and defend their rights.

Our Legal Highlights

A Victory for Students At CCNY

Despite many requests from the large Muslim population on campus, the City College of New York (CCNY) administration would not give students an appropriate space for prayer. Many students would end up praying in dirty areas, like stairwells and other odd spaces. They asked CAIR-NY to help advocate for an interfaith space that students of all faiths could use for prayer. CAIR-NY guided students on their rights and even helped to organize the students on campus. Together, we held a protest at the college and circulated an online writing campaign that got 3,700+ letters sent to the school!

Alhamdulillah, (thank God), these efforts have resulted in CCNY finally giving the students an interfaith space where they can pray! No more dirty stairwells for sujood (prostration)!





Our City, Our Vote

Local Law 11-2022 was an example of successful advocacy. This law allows lawful permanent residents and persons authorized to work in New York City to participate in municipal elections, beginning in 2023. Local Law 11 enfranchised over 800,000 immigrant residents in municipal elections, making New York City the largest jurisdiction in the country to offer voting rights to its non-citizen residents.


A lawsuit opposing this voter access law was filed shortly after it was enacted. The lawsuit seeks to invalidate Local Law 11 and restrict voters' access to the ballot box.

In response to the lawsuit, CAIR-NY, Asian American Legal Defense and Education Fund (AALDEF), Black Alliance for Just Immigration (BAJI), LatinoJustice PRLDEF, and Weil, Gotshal & Manges LLP intervened in the lawsuit to defend Local Law 11 and uphold non-citizens access to the ballot box.

Hope Against Hate: Uplift the Youth

As part of our commitment to anti-bullying work, we presented 22 anti-bullying workshops for students educating them on their rights and resources, engaging 1450 students.

Furthermore, CAIR-NY published a "Bullying Recourse Guide For Parents" in 7 different languages (English, Arabic, Farsi, Urdu, Bengali, Spanish and French) as well as a "Know Your Rights as A Muslim Youth at School" at School pamphlet for students.















Muslim Advocacy Day:

With coalition members, CAIR-NY and hundreds of fellow Muslims travelled to Washington D.C. as part of the USCMO's 2022 Muslim Advocacy Day. We met with elected officials in Congress and discussed the most pressing issues impacting American Muslims in today's political climate and worked towards building stronger relationships with our nation's lawmakers.

Financial Report


